Appendix A: Stakeholder interview structured questionnaire

Briefly introduce the project to the participant. Explain that it is funded by the Criminology Research Council, is happening in NSW, Victoria and SA, and that researchers from five universities are collaborating. Provide the Participant Information Sheet and Consent Form (which needs an independent witness, e.g. secretary). Explain that although their responses may be quoted in the final report, all identifying information will be removed. There is no way that they will be able to be linked to quotes in the report.

INTERVIEW FOR JUDGES, LAWYERS AND JURY ADMINISTRATORS

It is not clear to me what that means. Is it referring to the unanimous/majority requirements? Perhaps it could be rephrased.
- Item 9:** Statement: "Peremptory challenges made me uncomfortable".
Jurors come from a wide cross-section of society and not all of them may understand what that is referring to. Might it be better to refer to challenges without having to give a reason?


Item 3 asks a series of questions about juries, judges, lawyers and the general process that takes place during a trial. My concern is that a juror who has not been empanelled would have no basis for answering those questions because, unless they have previously done jury service, they would not have experienced a trial.

Item 4 canvasses a number of topics. Some could be answered without actual jury service but for the answers to others to have any value, the respondent would need to have had experience as a juror in a trial rather than simply have been called up for jury service.

Item 6 asks about preferences for trial by jury or trial by judge alone. Once again, although the person surveyed may have some views about that, it would not be based on experience in a trial as a juror. I therefore question the worth of the answers in this context.
