

#### INTRODUCTION

The Australian Institute of Criminology has established a national clearinghouse of criminological information to act as a central agency for the collection, storage, exchange and dissemination of bibliographical data on Australian and Australian-related criminological material.

This information is stored on computer and forms the data base of CINCH (Computerised Information from National Criminological Holdings), the Institute's computerised bibliographic service which provides rapid and comprehensive retrospective searches.

The Information Bulletin of Australian Criminology is published quarterly and is an integral part of this system, publishing in its 'Recent Publications' and 'Current and Recently Completed Research' sections all the new material which continuously updates the CINCH data base. It also contains information regarding past and forthcoming seminars in Australia, bibliographical activities of the J.V. Barry Memorial Library and generally aims to encourage a greater interchange of information between all persons interested in Australian criminology.

The success of the Information Bulletin depends to a large degree on material contributed to it by its readers, and persons who would like a statement of their research to appear or wish to publicise conferences or seminars are invited to complete the appropriate forms supplied with each issue and return them to the address below.

Readers will appreciate that the information contained in the Information Bulletin can only be as accurate and reliable as its source.

The Australian Institute of Criminology hopes that the services provided by CINCH and this Information Bulletin prove valuable to those interested in criminology and looks forward to the continued interest and assistance of its readers.

#### **EDITORIAL**

#### **READER EVALUATION SURVEY**

The Editorial Committee is grateful for the response it has received to the questionnaire regarding Volume 4. A large number of valuable comments were received, while some, though useful, reflected a misunderstanding of the objectives and resources of the *Information Bulletin of Australian Criminology*.

The Information Bulletin is intended as a bibliographical tool and does not supply interpretative or other original material. It comprises information supplied directly by its readers and information collected by the J.V. Barry Memorial Library. It has limited funds and manpower and is restricted in its role by the lack of facilities to seek out information not readily available. It is essentially a reactive service.

The Information Bulletin includes material on Australian and Australian-related publications, research and conferences. Information on overseas publications, research and conferences is excluded because it is readily available in a wide range of other publications.

A number of readers suggested that a section should be included to note recent changes in legislation. Such a service was provided up to the end of Volume 2. But, in response to a previous survey, this section was discontinued on the ground that it was duplicating material published elsewhere. Such publications as Australian Current Law and Australian Legal Montily Digest provide such information in a comprehensive and reliable form.

Other valuable suggestions received from readers were that abstracts of recent publications and a dresses of authors should be included in the Information Bulletin. However, because of lack of resources, these suggestions cannot be implemented at present.

One change that will be made as the result of readers' comments is the inclusion, in the section on Recent Publications, of references to feature articles from major Australian newspapers. These references will also be included in CINCH — the Institute's computerised bibliographical service.

Other changes presently under consideration are the inclusion of references to Parliamentary questions and debates, as well as a section, to be published annually, detailing criminology courses offered by tertiary institutions.

The Editorial Committee hopes that readers will continue to provide critical evaluations of the Information Bulletin, as well as providing the information upon which the Bulletin is based.

Four Flats Hawthorn provides accommodation and multiple support services for young offenders being released from Victorian correctional institutions.

Mr Hamilton-Smith, as outside evaluator of the programme, is maintaining cumulative records with respect to all young offenders being released from the two senior Youth Training Centres, Malmsbury and Langi Kal Kal during the years 1977 and 1978, for use as control group data.

Detailed records are being established on the progress of the residents within the Four Flats programme, including expectations in coming to the project, staff perceptions of each resident at various stages, information on relationships and life pattern whilst living in the flats, employment experience whilst in the programme, and perceptions and assessment made by the parole officer supervising the residents.

Regular weekly visits to the residence by one of the evaluation team allows an independent assessment to be made on the ongoing operation of the programme, processes of decision-making within the house community, and adaptation of the treatment programme to the needs of a variety of young offenders within an open community setting.

The First Progress Report, November 1977, will be supplanted by a further progress report in June 1978.

Two study groups were chosen from two different Jesuit secondary colleges within Australia. The first group, the Experimental Group consisted of twenty-two Form IV students boarding at Xavier College in Kew, Victoria. The second group, the Control Group, consisted of fifty-eight Form IV students boarding at St Ignatius College, Riverview, at Lane Cove, New South Wales. Both groups of students were given a forty item Attitude Survey

on Crime and Punishment (Biles 1968) in February of their

Form IV year.

The Experimental Group of twenty-two Melbourne students visited Turana Youth Training Centre in small groups of five and six on several occasions during that year. They visited on Friday evenings a security section in order to play volleyball or basketball with the trainees. In February of the following year, both groups were again administered the Biles Attitude Survey.

Both groups were well matched on a large range of factors, and the changes which were measured in the attitudes of the experimental group, who had been regular visitors to the Youth Training Centre within Victoria, were seen to be significantly different to the changes in attitude measured in the control group over a period of twelve months.
