## EDITORIAL

The Australian Institute of Criminology will be hosting the Seventh Conference for Librarians in the Criminal Justice System at Burgmann College, Australian National University from May 29-31, and at the time this Bulletin goes to press Institute staff are making final preparations for the Conference.

The theme of the Conference is *Information for the 1990s and Beyond*. Speakers will be focussing on both the information resources available to criminal justice personnel and also on the technological advances that enable us to access these resources quickly, cheaply, and from remote locations. We extend a welcome to participants at the Conference, who represent a wide range of organisations, and note with pleasure the involvement of three overseas participants, two from New Zealand and one from the USA.

The Institute has recently had double cause to celebrate with CINCH, the Australian Criminology Database. In April this year we achieved the milestone of adding record number 20,000 to the Database. CINCH was initiated as an internal information system in 1976, as part of the Institute's role as a clearing house of criminal justice information. In recent years the Database has shown steady growth with between 1,500 and 2,000 indexed records being added each year.

Also in April the Institute celebrated the fifth anniversary of CINCH being a publicly-available online database. Initially CINCH was available through ACI Computer Services's AUSINET service. More recently it has been available through the National Library's OZLINE network.

It is gratifying to note the steadily growing support for CINCH measured in terms of the increased online use of the Database. With the development of the AUSTROM CD-ROM project, CINCH will be become even more readily accessible, particularly for overseas users.

### Australian Institute of Criminology

Ms Susan Pinto, Senior Research Officer at the Australian Institute of Criminology since March 1989, will be leaving in August to study at the University of Toronto, Canada for a Master of Arts in Criminology. She has been awarded a University of Toronto Open Fellowship. During her time at the Institute Susan has worked on a number of projects, including reports for the Department of Immigration on Immigration Detention Centres in Australia, and Youth Suicide for the Department of Employment, Education and Training. She has co-authored papers on political violence, and on prostitution laws in Australia, and is currently researching gambling, serial murders, and homosexual laws in Australia.

## DR NGAIRE NAFFINE(E) : A BIBLIOGRAPHIC NOTE

Dr Ngaire Naffine, Research Fellow at the University of Adelaide and currently Visiting Scholar in the Law Department, RISS, Australian National University, is a well known name in the areas of women in the criminal justice system, and juvenile justice. Well known name? A point of confusion is that Dr Naffine, author of *Female crime*, is the same person as the author of the *Naffin report*, the South Australian report into the substantive law of rape.

Dr Naffine changed the spelling of her name in 1987, and both forms will be found in catalogues, bibliographies and indexes.

In the meantime, an issue of particular interest is that a new book, written by Dr Naffine and published by Allen and Unwin, entitled *Law and the sexes : explorations in feminist jurisprudence*, is due out in July this year.

## STANDARD GUIDELINES FOR CORRECTIONS IN AUSTRALIA

After a number of years of development and preparation *Standard guidelines for Corrections in Australia* was published last year by the Conference of Correctional Administrators.

The publication was prepared from comments provided by each of the Australian jurisdictions, New Zealand, and the Australian Institute of Criminology. It is made up of five sections:

- Guiding principles
- Definitions
- Standard guidelines for corrections
- Standard guidelines for community based corrections
- Standard guidelines for prisons.

The 1989 document is particularly significant in that it represents the first time in Australia that standard guidelines have been developed for community based corrections. It has evolved from a number of earlier publications, including:

- *The Minimum standard guidelines for Australian Prisons* (1978, and later edition, 1984), edited by C.R. Bevan, Assistant Director, Training, of the Australian Institute of Criminology; and
- *Minimum standard guidelines for Corrections in Australia and New Zealand* (1987 draft).

*Standard guidelines for corrections in Australia* is available in Australia from relevant State or Territory Corrections Departments.

## OZLINE CHANGES

The OZLINE network is operated by the National Library of Australia and provides online access to a number of Australian databases including CINCH and APAIS.

Effective from June, AUSPORT, a new database covering Sport in Australia will be available through OZLINE. AUSPORT is produced by the National Sport Information Centre, Australian Institute of Sport, Canberra.

Users of OZLINE should also note the following changes to connect hour costs and offline prints that take effect from August 1, 1990:

In addition, OZLINE is available for use on Saturdays from 10 am to 6 pm for a trial period.

## CCH's CRIMINAL LAW LETTER

Late in 1988 CCH Australia launched a new publication, *The Australian and New Zealand*

*Criminal Law Letter*. Issued monthly, this newsletter answers a need for a practical source of legal information, offering legal practitioners in particular a broad overview of criminal law developments.

Subscribers to the *Criminal Law Letter* receive eleven issues a year, and the publication is written in a concise, non-technical style and covers a broad range of topics. A typical issue includes a feature article on a topical subject and concise explanations of Commonwealth, State and Territory legislation which has recently commenced. Also included are useful lists of bills, notes on the latest developments in practice, and case digests providing concise summaries of recent High Court and other important cases.

Recent issues have covered areas such as sentencing, confiscation of criminal profits, DNA profiling, and whether there is a common law right to a speedy trial.

A subscription to *The Australian and New Zealand Criminal Law Letter* costs \$218/year for a two year, or \$240 for a one-year subscription, plus a \$20 installation charge. Each subscription includes quarterly cumulative indexes and an annual index. For further information contact:

**AUSTRALIAN PRISON LIBRARIES :  
MINIMUM STANDARD GUIDELINES**

For several years legal and criminal justice librarians in Australia have recognised the need for minimum standard guidelines for Australian prison libraries. In 1987 the Australian Library and Information

Association (ALIA) then known as the Library Association of Australia), commissioned a Working Party to prepare a document, which has now been endorsed and published by ALIA. The work of compiling *Australian Prison Libraries : Minimum Standard Guidelines* has been undertaken by Mr Philip Roberts, Library Adviser, Queensland Department of Family Services and Aboriginal and Islander Affairs on behalf of the Working Party.

The published Minimum Standard Guidelines will be launched on May 29, 1990 by the Hon Jeffrey A. Miles, Chief Justice of the Supreme Court of the ACT, at a function at the Australian Institute of Criminology.

With the release and launch of this publication, it is an appropriate time to acknowledge the contribution of many people who have worked to achieve this end. Particular note should be made of the contributions of Rob Brian and the late Neil Donahoo, in the late 1970s and early 1980s, and that of Philip Roberts as compiler of the final document.

For those seeking to improve the quality of prison libraries in Australia, the publication of *Minimum Standard Guidelines* is an important step. The task ahead was spelt out in a resolution moved and passed at the first Australian Libraries Summit in 1988:

...That the LAA [now ALIA] consult with prison authorities, State/Territory libraries and other relevant bodies to achieve the most appropriate and effective mechanisms for providing library services to prisoners, and that it takes other steps as necessary to encourage the implementation of minimum standard guidelines for these services.
