EDITORIAL

Readers of the Australian Criminology Information Bulletin would have noticed that this publication provides information on forthcoming Australian and overseas conferences that would be of interest to individuals or organisations involved in the criminal justice field. Conference organisers wishing to publicise forthcoming conferences should forward the information to the Australian Institute of Criminology for inclusion in the Bulletin.

The Eighth United Nations Congress on the Prevention of Crime and the Treatment of Offenders was held in Havana, Cuba from August 27 to September 7 this year. Following an invitation from the UN Crime Prevention and Criminal Justice Branch in Vienna, I attended the Congress to demonstrate and speak about the United Nations Criminal Justice Information Network (UNCJIN). (See below for a short report on the Congress)

Also in the second half of the year, the Sixth Annual Conference of the Australian and New Zealand Society of Criminology was held in Sydney from September 24 to 26. Unfortunately this date conflicted with the Australian Criminal Law Convention, held in Hobart, and this meant reduced numbers participating, but the Conference still provided an attractive and stimulating program. The sessions on crime statistics were of particular interest. A highlight of the social side was a light-hearted address at the Conference dinner by Dr Arie Freiberg, from Monash University's Law School.

8TH UN CRIME CONGRESS

This is a short report on the Eighth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, held in Havana Cuba from August 27 to September 7, this year.

I was invited to Cuba to demonstrate UNCJIN at the Congress and also speak about UNCJIN at the Plenary Session of the First UN Workshop on Computerization of Criminal Justice Information, which has held in conjunction with the Congress. In addition, I demonstrated the Sentencing Information System developed by the Judicial Commission of New South Wales.

I was assisted in my work by the use of an NEC ProSpeed CSX portable computer, made available for the period of the Congress by NEC Information Systems Aust P/L. I am indebted to Mr Robert Neil of NEC for arranging for the PC to be

made available. One of the applications of the computer in Havana was to demonstrate a version of CINCH, the Australian Criminology Database, housed on the computer's hard disc drive.

A feature of the Congress, and of previous UN Crime Congresses, was the extensive volume of publications and documents, both official and otherwise, distributed and made available for participants. The official material included Conference documents, such as agenda items, working papers, and other draft documents. Also in this category were documents issued by affiliated non-government organisations that were involved as participants at the Congress. The non-official material included a wide range of publications, promotional material, and other documents distributed in Havana by participants. A quantity of these publications and documents are currently being incorporated in the collections of the J.V. Barry Library.

An advance mimeograph version of the final report of the Congress (UN Document Number A/CONF.144/28) has already been issued, and has been received at the Institute. The Report will also be issued in printed form as a United Nations sales publication. The Report includes decisions of the Congress, such as draft instruments and resolutions recommended for adoption by the General Assembly.

- . One loan of a microform

A charge of \$6 will apply to the following:

- . Photocopy of one item

These charges will apply unless clients have organised a reciprocal no charge policy. Generally speaking, the Institute already has reciprocal agreements with Commonwealth departments or statutory authorities, and a range of criminal justice agencies.

In a number of instances, some of these agencies which we do not charge have placed heavy demands on our Inter-library Loans Officer. Where inter-library loan traffic is heavily in favour of other agencies (i.e. is not a genuine reciprocal arrangement) we ask that requesting libraries use the Institute as a library of last resort.
