Malcolm has undertaken to forward police news items of general interest to be included in this Bulletin.

As part of a focus on information needs of police agencies, commencing with the next issue, we will be initiating a series of profiles of individual police libraries. The first in the series will be the Queensland Police Academy Library.

AUSTRALIAN EMERGENCY SERVICES LIBRARIANS WORKSHOP

Report on the Australian Emergency Services Librarians Workshop, September 8-13, 1991, Australian Counter Disaster College, Mt Macedon, Victoria

Twenty-five librarians servicing police, fire, ambulance, emergency services organisations, forestry and environmental authorities throughout Australia participated at the Workshop with three interested non-librarians.

Fourteen speakers delivered papers on issues ranging from the culture of emergency services organisations and hazards in the community, to the role of library-based information services in the modern police service, library cooperation, thesaurus and database construction, and the Australian Disaster Management Information Exchange (ADMIX). Discussion sessions grouped people by service, by state and randomly.

The police librarians' group included representatives of all Australian Police authorities with the exception of the Tasmania Police and the Australian Federal Police. It was the first time in six years that Western Australia's

police librarians had attended such a gathering and the group decided that increased cooperation would be facilitated by a newsletter issued twice a year. The acronym PLANZ (Police Libraries in Australia and New Zealand) was chosen as its title. The group accepted an offer from Malcolm Cram of the NSW Police Service to be editor of the newsletter.

It was agreed that each police library should endeavour to join ILANET, a network providing an electronic inter-library loans facility, a bulletin board and gateways to several online catalogues and database services. It was also decided that serials holdings of police libraries be contributed to the National Union Catalogue of Serials, NUCOS, rather than be brought together for a hard copy serials union list.

The police librarians' group also discussed computerisation. All Police Libraries, except Queensland and NSW, have computerised library systems of some kind. Queensland is planning to install the AIMS library system, the same system as the Australian Police Staff College. AIMS is a sophisticated system capable of handling small, medium and large library collections. It is one of three automated library systems which the NSW Police Library Service is considering.

All libraries dealing with specialised information in areas like policing, fire fighting or ambulance work find commonly-used subject headings, such as Library of Congress, unsatisfactory. The most common criticism is that these subject headings are too generalised and do not use Australian terminology.

There is a need to develop a thesaurus or structured list of subject headings using the terminology of the area concerned, clearly indicating the scope of each heading and its relationship with others in the list. Anne Robinson from the Defence Information Unit delivered an interesting and systematic paper on thesaurus construction drawing on her extensive experience constructing DEFTEST, a thesaurus of defence terminology. She made the point that without an automated system, thesaurus construction is extremely difficult, if not impossible.

ADMIX (Australian Disaster Management Information Exchange) was demonstrated during the workshop. This electronic bulletin board has been established under the sponsorship of the Natural Disasters Organisation in association with the Centre for International Research for Communication and Information Technologies (CIRCIT). ADMIX is

intended to serve as a primary source of reliable information so as to prepare for potentially hazardous events. ADMIX is not intended to provide assistance during an actual emergency. It will serve as a central source of timely information about counter disaster organisations and their activities, training courses and instructional materials, literature lists, public and private sector information services, calendars of events, contacts and online-databases. During the final session of the workshop the ambulance, fire and emergency service librarians decided they should use ADMIX to strengthen their communications links.

The workshop was a very worthwhile experience in learning and interaction. It was the first librarians' activity organised by the ACDC. All participants wanted another to be held in two years time.

ABS CAUSES OF DEATH STATISTICS

For some years the Australian Bureau of Statistics has published Causes of Death statistics, derived from data made available by the Registrars of Births, Deaths and Marriages in the states and territories. The most common published form of the data is the annual publication: *Causes of Death, Australia* (ABS Catalogue No. 3303.0).

This publication contains a summary of the deaths data and researchers, practitioners and students in the criminal justice field should be aware that tables containing more detailed cause of death information by sex and/or age group at death are available on microfiche from any ABS office. These tables are available on a state or territory of usual residence or state or territory of registration basis.

The causes of death are classified according to the Ninth (1975) Revision of the World Health Organization's International Classification of Diseases, which was adopted for worldwide use in 1979. Particulars relate to the underlying cause of death, which the WHO has defined as the disease or injury which initiated the train of morbid events leading directly to death. Accidental and violent deaths are

classified according to the external cause, that is, to the circumstances of the accident or violence which produced the fatal injury rather than the nature of the injury. It should be noted that Causes of Death statistics relate to calendar year, not financial year (June/July).

With the detailed microfiche series, Table RG3 includes deaths by state/territory (and total Australian) x cause of death x sex x 5 year age groups. For the criminal justice field, this table is usually the most useful, as it covers most contingencies.

Acquired Immune Deficiency Syndrome (AIDS)
Deaths where AIDS was determined as the underlying cause are included in:

240-279 Endocrine, nutritional and metabolic diseases and immunity disorders.

Within this group, the number of AIDS related deaths registered in 1989 (the latest group of annual figures released) was 392. This comprises 256 directly attributed to AIDS and 136 where AIDS was mentioned on the medical certificate as cause of death. The 392 figure represents a 70 per cent increase on the 231 AIDS related deaths registered in 1988.

AUSTROM

In the last issue of this Bulletin, there was an announcement about the release of the latest version (Vol.2, No.1) of the AUSTROM CD-ROM. We neglected to mention that this new version contains a number of software enhancements which represent a considerable advance on earlier versions of AUSTROM. One new feature is a CROSS SEARCH facility which allows the searcher to search across a number of fields within each database. These fields are title, abstract, descriptors (major and minor), and identifiers (including variations such as geographical names). The new version also has an improved print option.
