Editorial

The Eighth Conference for Librarians in the Criminal Justice System, organised by the Australian Institute of Criminology, is scheduled to be held from 31 March to 2 April this year. The venue for the Conference is the Australian Police Staff College, Manly. This is only the second time in this series of Conferences that it has been held away from Canberra. The first occasion was in 1979, also in Sydney, at the University of New South Wales.

The theme of the Conference is Criminal Justice Cooperation: Libraries Showing the Way.

We will be attracting a wide, geographical representation to this year's Conference. It is particularly gratifying to welcome six overseas participants: three from New Zealand, two from Spain and one from the USA. In addition, five states and two territories of the Commonwealth will be represented.

CINCH and OZLINE

CINCH, the Australian Criminology Database

After the first update for 1992, CINCH now has 22,736 records.

The National Library's OZLINE has a special offer for online users of CINCH for April. CINCH will be free for all OZLINE users for 30 minutes during April. Please note, this offer does not cover offline prints and each network centre is allowed 30 minutes online time, NOT each individual password.

OZLINE Charges for 1991-93

As from 1 July there will be new usage charges of OZLINE: \$90.00/hour connect time
25 cents per offline citation plus
\$2.00 per printout
\$1.00/month stored searches
\$60/year service fee.

New for 1991-93

From July 1992, users will be able to take out a subscription to OZLINE. This is an alternative to the normal online connect time usage charges. There will be two subscription levels available.

- (i) \$1500/yr subscription for unlimited use of OZLINE for the year. Payment is to be made at the start of the year. No service fees will apply, but normal offline print and search storage fees will be charged.
- (ii) \$660 subscription will allow 12 months or 12 hours of use, whichever is reached sooner. This provides a substantial discount on the normal \$90/hr rate, and if a subscription is used up in 4 months a further subscription can be purchased. No service fee will apply, but normal offline print and search storage charges apply.

Schools

The current arrangements, which allow schools to use up to five hours per year at the special rate of \$25.00/hour will be maintained. Of course if you wanted to use OZLINE much more you are welcome to take up one of the subscriptions above!

The Australian Police Staff College Library

1. The College

The Australian Police Staff College, formerly known as the Australian Police College, was officially opened on 25 October 1960. The College now comes under the administration of the Commonwealth Attorney-General's Department and provides senior management and executive development training at the national level for Australian Police Forces and law enforcement agencies. Since 1960, more than 3,000 police have attended College courses, including over 1,200 commissioned officers. Apart from Australia and New Zealand, course members have come from the USA, Malaysia, Papua New Guinea, the Pacific, South-East Asia and Africa.

The Australian Police College became the Australian Police Staff College by resolution of the Board of Control on 5 December 1986. The Staff College is governed by a Board of Control, which comprises the Commissioners of the Australian Police Forces and the Secretary of the Attorney-General's Department.

The primary role of the College is to improve significantly the corporate performance and productivity of Australian law enforcement agencies by developing superior managers and executives. The long term goal of the Australian Police Staff College is to be recognised as Australia's foremost educational institution providing outstanding educational programs and services to Australia's law enforcement and public safety practitioners and agencies.

2. Range of Programs

The College conducts a variety of programs and courses, including:

- Senior Police Executive Officers' Courses
- Police Management Development Programs
- Senior Executives' Program
- Specialist Training Courses
- Critical Issues Seminars

3. Library

The Australian Police Staff College Library is a specialised Library servicing the particular specialised information needs and requirements of the Australian Police Forces. The collection has been developed since the Library's inception in 1960 and accordingly has maintained a collection in the areas of: Police Administration and Management, Management, Social Sciences, Criminology, Law, Forensic Science and Technology.

The College Library is a resource services facility. It provides materials and staff to meet the educational needs of students, lecturers and other members of the college community and law enforcement community, through a multi-sensory approach. The services make provision for:

Reading, browsing, listening, viewing;
individual study involving the use of print
and non-print material;
borrowing of materials;

production of materials;
organisation of materials for effective use.

The College Library provides material and services for library users (staff, students and other members of the law enforcement community) through the development of a well rounded multi-media collection, based on the desired outcomes of the curriculum, for use in both teaching and learning situations and for recreational purposes.

The Library currently holds approximately 16,000 titles including monograph and audio visual material. Journal subscriptions include some 400 titles. Included in the titles are police journals, both local and international; business and management; law and criminology. The rest consist of other topical titles including current affairs; subject related to the College's curriculum, technology and general interests.

Aside from an extensive book collection, the library also holds videorecordings and audio recordings.

The Library management policy is one of being aware of, and participating in, the latest information technology developments with regard to bibliographic control and information retrieval. The Library utilises the AIMS library system, with two OPAC terminals for library users. In addition, a dedicated microcomputer is utilised by the Library to access information networks both within Australia and overseas.

These networks and services include OZLINE, AUSINET, DIALOG and ILANET.

The Australian Police Staff College liaises with all other police libraries in Australia as well as the tertiary institution libraries and through the use of these networks is able to provide materials requested by its clients through the inter-library loan facility, all over Australia.

The Library's client services include:

- Provision of a current awareness services;
- Assisting and preparing bibliographies and special selected materials for use in the college curriculum and Critical Issues Seminars;
- Abstracting and indexing of all incoming journals, to provide current and timely access to trends in management and policing;
- Online database information retrieval;
- Reference and research services to all APSC staff, serving members and personnel in the Australian Police Forces, personnel in the Attorney-General's portfolio, and others at the discretion of the Librarian or Director and Dean of the APSC;
- Maintain and organise a collection of past and current course papers and related materials;
- Developing and fostering networks vital in the provision of up-to-date, timely, and cost-effective information for its clientele;
- Teaching information literacy, library skills and basic research methods to course members.

New Publications

Sydney University's Institute of Criminology

Aboriginal Perspectives on Criminal Justice edited by Chris Cunneen

Aboriginal Perspectives on Criminal Justice brings together a collection of papers by Aboriginal and non-Aboriginal writers. Chapters by Pat O'Shane, Evelyn Crawford and Bill Craigie discuss the Royal Commission into Aboriginal Deaths in Custody and the issue of institutional racism, and demand that more attention be paid to the relationship between violence, social disintegration and the failure to recognise land rights. They point to the failure to involve Aboriginal people in the planning, design and management of criminal justice programs, and question the ability of the states to implement recommendations by the Royal Commission. The death of David Barry in Lotus Glen Prison is the subject of Jason Behrendt's chapter, and again raises the issue of judicial racism. Kevin Kitchener discusses the impact of Summary Offences legislation on Aboriginal communities. Sharon Payne examines the question of violence against Aboriginal women and their treatment in the justice system. She also looks at the issues which arise from the Royal Commission into deaths in custody of eleven Aboriginal women.

Doing Less Time: Penal Reform in Crisis by Janet Chan

The story of the Release on Licence Scheme in New South Wales is one whose ending is well known: the scheme was abruptly terminated by the government in August 1983. Four years later Rex Jackson, the former Minister for Corrective Services, was found guilty of accepting bribes for early release and given a lengthy prison sentence. A new police inquiry recommended that the matter be turned over to the Independent Commission Against Corruption for further action.

This sensational and dramatic conclusion obscures a less familiar, but no less important, part of the story: the release scheme itself—how it was conceptualised, operationalised, and modified; what it meant to the people involved; how these problems were dealt with; and whether in the end, its objectives were realised.

In her book *Doing Less Time*, author Janet Chan looks at the genesis of the release on licence program in the early eighties. She provides an in-depth account of the scheme and of the theories of prison reform, decarceration and social control which lay behind its introduction in New South Wales prisons. *Doing Less Time* looks at the neglected aspects of the release scheme. Interviews with those involved with its day-to-day operation record the story of the scheme itself—one marked by high expectations and deep disappointments. Dr Chan also looks at the reasons for its failure and the implications for penal reform and the ideology of prison as a last resort in the years that followed.
