### Editorial

This issue of the *Bulletin* contains two items that follow on from the recent Criminal Justice Librarians' Conference in Sydney.

In the concluding session of the Conference, there was a strong expression of support for moves to have a full set of NCJRS microfiche available in Australia. There have been some moves on this matter, and this issue reports on some of the contacts that have already been made.

In addition, I have already noted the excellent representation of overseas librarians at the Conference and we have included an article profiling these librarians and the agencies that they represent.

### NCJRS Microfiche

During the recent Criminal Justice Librarians' Conference, a number of participants commented on the difficulty of gaining access to NCJRS microfiche. No Australian library holds the entire 30,000+ microfiche collection.

The NCJRS Database, produced by the US National Criminal Justice Research Service, is widely used in Australia, either online through DIALOG or by using the NCJRS CD-ROM, published by OPI. Many of the reports retrieved through literature searches are only available in microfiche form. Participants at the recent Conference indicated strong support for any initiative that would make the entire NCJRS fiche collection available in Australia.

There are two alternatives currently available to Australian librarians wanting to access the fiche:

1. Check with a range of Australian libraries that have some holdings from the fiche collection. These include the National Library, the State Library of NSW, and the Australian Institute of Criminology.

2. Open a deposit account with a minimum of US\$100 with NCJRS and order individual microfiche documents. Once the account has been established, the cost of each order is automatically deducted.

The Institute is currently surveying Australian libraries to assess the extent of Australian holdings. The National Library has been approached and it would be appreciated if other libraries with NCJRS fiche holdings would indicate the extent of holdings to either John Myrtle or Fran Ballard at the Australian Institute of Criminology. We will report on any responses in forthcoming issues of this *Bulletin*.

Over the years the Institute has purchased a range of NCJRS microfiche, including a number of SLIMS (Selected Libraries in Microfiche). We have now broken up these different packages and have incorporated the fiche holdings into one consolidated run, filed in NCJRS number order. We estimate that the J.V. Barry Library holds between 2,500 and 3,000 of these microfiche documents. They are available for inter-library loan. However, we are unable to provide either fiche or paper copies of our original fiche documents. If you are requesting an inter-library loan, please quote the NCJRS number. Please remember that we hold less than 10 per cent of the entire fiche collection.

The Institute has also had discussions with the National Library about the possibility of obtaining the entire NCJRS collection and locating the collection at the National Library. We will report further in this *Bulletin* on progress with these discussions.

## Criminal Justice Librarians' Conference Overseas Contingent

This is an addendum to the report on the Eighth Conference for Librarians in the Criminal Justice System included in the April issue of the *Australian Criminology Information Bulletin*.

One notable feature of the Conference was the presence of a strong overseas contingent. These included two participants from Spain, three from New Zealand, and one from the United States of America. During the Conference we talked to these overseas participants about their work and obtained some background information about the agencies that they represent.

### Police School of Catalonia Spain

Ms Elisabeth Calatayud, Chief Librarian and Ms Rosa Pujante, Cabinet of the Director, represented the Police School of Catalonia (Escola de Policia de Catalunya), Barcelona, Spain.

For Rosa and Elisabeth, their goal was to meet colleagues from other police college libraries and to compare aims and directions at an international level. They also aimed to set up an information exchange program between the various New Zealand and Australian Police College libraries.

### Police Documentation Centre

CEDOCPOL (Police Documentation Centre of the Police School of Catalonia) serves the students of the College as well as all members of the police force and researchers. CEDOCPOL has a staff of five headed by Elisabeth Calatayud as Chief Librarian. The Centre's collection supports the teaching and student needs of the College, and has sections specialising in police techniques, police cooperation, police training, law and criminology. The collection currently consists of 11,000 monographs and 87 journal titles.

The library has access to various online services and CD-ROM products. Online access includes Spanish legislation databases, DIALOG, UNCJIN and BRS. The following CD-ROM products are used:

- B.D.A. (Aranzadi Data Base)  
Reference of all legal material published since 1930. From 1990 it is full text.
- CIA World Factbook  
Published by the CIA, this ROM gathers together information from 248 countries about geography, society, government and economy.
- Documentacion de Medios  
Contains information from national and international press.
- Terrorist Group Profiles  
Information about present-day terrorist groups.

### The Police School of Catalonia

The Police School of Catalonia is one of three police colleges in Spain. It was established in 1985 and is responsible to the Department of the Interior of the Generalitat de Catalunya. The School co-ordinates and trains all the local police forces and has responsibility for its own police force (Mossos d'Esquadra).

The Director of the School is appointed by the Councillor of the Interior of the Generalitat. In

December 1989 Mr Jesus M. Rodes was appointed Director of the School.

The functions of the Police School include:

- a) To train the officers of the Autonomous Catalan Police Force/Mossos d'Esquadra and of any other police force which depends or may depend on the Generalitat.
- b) To train the officers of the Local Police Forces of Catalonia
- c) To advise the Directorate General of Public Order in the selection process for the Autonomous Catalan Police forces. To give support to those Town Councils which request help in the selection process for the Local Police forces.
- d) To research, study and disseminate topics related to police forces and public order.

All the staff at the Police College are civil servants, with the lecturers coming from the autonomous University of Barcelona. The College runs courses for both police recruit training and senior management training courses, up to the rank of inspector. In addition, the college runs many special courses on topics such as domestic violence training, environmental laws, and drugs.

The Police School of Catalonia is currently adopting a similar approach to that of Queensland, where eventually all commissioned officers will hold a university degree. At present the Police School is setting up an affiliation with the University of Barcelona. At this stage, it is intended that the new degree courses will commence in 1993.

The Police School hosted the First Catalan Seminar of Police Documentation Centers on May 21 and 22 this year. During the Seminar, the following major topics were addressed:

- Development of libraries and police documentation centres
- Experience and developments in different centres
- International cooperation
- New technologies applied to the police and criminal justice field; looking in particular at the application of online access to databases, CD-ROM products, and the use of videotext.

### **Department of Justice New Zealand**

Elizabeth Buckley is the Library Manager of the Department of Justice in Wellington, New Zealand and had previously attended the Sixth Criminal Justice Librarians' Conference, held in Canberra in 1988.

#### **General Library Services**

The library's primary task is to provide a comprehensive library service to Head Office staff. The staff are involved in providing a full range of library services from acquisition and organisation of stock through to an SDI service. They are full participants in the New Zealand Bibliographic Network (NZBN) and also access LEXIS, DIALOG and KIWINET. They have recently subscribed to the AUSTROM CD-ROM.

#### **Library Services to Penal Institutions**

A major research project currently being undertaken by the Department of Justice is to explore the feasibility of the Department establishing an effective library service in prisons, in conjunction with assistance from the local and polytechnic libraries.

The research on this project recommended that the Department of Justice fully fund and establish Library Resource Centres in the prisons to support recreational reading services to inmates, education programs and to satisfy the needs of the corrections staff.

The Resource Centres are to be staffed by fully qualified library personnel who are to establish and manage the Centres. The Department of Justice are drawing up the guidelines as a frame of reference for the implementation of the plan. They are preparing proposals for acquiring the services on a contract basis from the local public and polytechnic libraries. The local/polytechnic libraries will provide a range of support to the project in the form of staff, book vans and advisory services.

#### **Royal New Zealand Police College, New Zealand**

Two staff members from the Royal New Zealand Police College Library attended the conference; Ms Maria Andre, Librarian, and Ms Margaret Vine, Deputy

Librarian. Maria had attended the two previous Criminal Justice Librarians' Conferences in 1988 and again in 1990.

The Police College Library came into existence in 1958. It was originally established as a small collection of text books to be used for training purposes by police cadets and recruits.

Today the scope of the library is to collect information on all aspects of police work and to make the information available to all members of the police force at stations throughout New Zealand.

The collection itself is now beginning to reflect the major changes that have come about in the field of policing and has grown to include approximately 35,000 monographs and 38,000 microfiche. The library is also unique in the southern hemisphere in that it holds the entire National Criminal Justice Reference Service on microfiche.

The library offers an in-depth research service for members throughout New Zealand and much of the library staff time is taken in providing this service. This service is facilitated by the use of automated serials and cataloguing and CD-ROMS such as NCJRS, AUSTROM and WILSON. They are also online to the New Zealand Bibliographic Network.

Recently, all civil employees of the police department became non-sworn members of the police force. They are now subject to police rules and regulations and have forfeited all their public service conditions.

The Police Department has set up a research centre which aims to centralise all the research being done by the New Zealand Police Department. The centre will set up a database which will identify subject of research, author, funding, and length of the project. The library's role will be to act as a depository for all the completed research papers.

### **Rutgers School of Criminal Justice, United States of America**

Ms Phyllis Schultze, Librarian for the School of Criminal Justice at Rutgers, the State University of New Jersey, not only manages one of the major criminal justice libraries in the United States, but is also co-convenor of the World Criminal Justice Library Network. This was her first visit to Australia.

#### **The Rutgers School of Criminal Justice**

Originally established in 1921, the Library is part of the overall University library system. Located in the same building as the School of Criminal Justice, and adjacent to the Rutgers Newark Law Library, the collection primarily services the research needs of the faculty and students of the School of Criminal Justice and the larger Rutgers community.

In 1968, the New Jersey State legislature authorised and directed Rutgers, the State University of New Jersey, to establish a School of Criminal Justice. In authorising the School, emphasis was given by the legislature in three areas: instruction, research and leadership. The School is a major national and international centre for scholarly research on all aspects of delinquency, crime and criminal justice.

### **The Criminal Justice/NCCD Library**

The Library of the National Council on Crime and Delinquency (NCCD) was purchased by the University in 1984 to enhance the instructional and research needs of the School.

Long regarded as one of the world's premier collections in criminology and criminal justice, the Library contains some 11,000 monographs, over 250 current periodical titles, more than 4,000 dissertations, and 35,000 published and unpublished reports. Consisting of both national and international publications, the collection provides a wide range of published research dating back over 50 years.

Realising the international nature of criminal justice, and the international interests of the faculty it serves, the Library has greatly increased its acquisitions of foreign language materials, including French, German, Spanish and Italian.

### **Criminal Justice Abstracts**

The primary access tool for the collection is Criminal Justice Abstracts (CJA). Drawing on materials from the collection, CJA publishes approximately 1,800 abstracts of significant articles, books, reports and dissertations per volume. Currently a CD-ROM edition of CJA is under discussion. The Library has all the material indexed in CJA.

Increased coverage is being given to international publications. Last year alone, research documents on about 60 countries were abstracted, and materials originating in French, German, Italian and Spanish are regularly abstracted.

### **World Criminal Justice Library Network (WCJLN)**

The World Criminal Justice Library Network was formed at a meeting of librarians and criminal justice information specialists in April 1991, at the Rutgers School of Criminal Justice.

A good representation of library managers attended this inaugural meeting and were unanimous in their recognition of the increasing demands and pressure placed on criminal justice libraries because of the globalisation of crime and responses to it, and because of an information explosion in these fields. As it is clear that no library can hope to collect everything or service the diverse and increasingly international needs of clients, the conference identified the need to save resources through pooling of information and services.

Planning is now underway for the Second Conference of the World Criminal Justice Library Network. The Conference scheduled for April 1993, will aim to make actual commitments and specific agreements and to build upon the initial work stated at the 1991 Conference.

## **Database News**

### **CINCH**

The Second 1992 update for the CINCH Database has been loaded on OZLINE. Overall, the Database now contains approximately 23,000 records. The third update for the year should be available by the end of June.

Users of CINCH are reminded that it is available in three forms:

1. Online, through the National Library of Australia's OZLINE Service
2. On CD-ROM as part of the AUSTROM disc, which is jointly published by INFORMIT and the National Library
3. On floppy diskette. In this form, 1988+ records are sold on subscription for users of PC-based database software.

### **INFORMIT**

Over the past year, INFORMIT, the publishers of the AUSTROM CD-ROM, have increased the range of CD-ROMs on offer and are firmly established as the leading CD-ROM publisher serving the Australian library market. The latest INFORMIT publication is Arts, Heritage and Environment on CD-ROM which was released in April. It is an annual disc and sells for \$245. The CD-ROM includes fourteen Australian databases. The most significant of these is HERA (Australian Heritage Information System) which is produced by the Australian Heritage Commission. HERA was initiated in 1987 and is currently also available online through both OZLINE and AUSTRALIS. The version of HERA on this new CD-ROM contain 12,100 records.

Sales of AUSTROM, Australian Social Science, Education and Legal Databases on CD-ROM, have increased significantly in the past year and there are currently more than 300 subscribers.

### **OZLINE**

As mentioned above, HERA (Australian Heritage Information System) is now available as part of the National Library's OZLINE Service.

Another new database has been added which will attract no user charge. This database, called FREE, is designed as a training aid. It contains 5,000 1985 APAIS records and will remain static. The National Library's aim with FREE is to provide a facility for OZLINE users to brush up their searching skills without worrying about mounting connect time charges.

## National Clearinghouse for the Defense of Battered Women

Courtesy of Kathy Laster, of Melbourne University's Criminology Department, the Library of the Australian Institute of Criminology has received information on the activities of the US-based National Clearinghouse for the Defense of Battered Women.

The Clearinghouse, created in 1987, provides critical assistance, resources, and support to battered women who have killed or assaulted their abusers while attempting to protect themselves against brutal and life-threatening violence. It also provides assistance to battered women who have been coerced into crime by their abusers.

The Clearinghouse offers technical assistance to defence lawyers, maintains a comprehensive resource bank, provides direct support to battered women in prison, coordinates a national network of advocates working with women in prison, and provides community and professional training seminars.

The resource library of the Clearinghouse contains over 1,400 cases and articles relating to battered women defendants and their legal defence. This material is listed in an annotated bibliography and a statistical package is also available, covering a variety of topics relevant to partner homicide, domestic violence and battered women in prison.

The new premises will be a shop front and centre which will provide support and assistance services such as a private discussion area for victims, a meeting area for support groups, and a reference library and research facility.

## NCADA

The National Campaign Against Drug Abuse (NCADA) will continue for the next five years. The decision came out of the April meeting of the Ministerial Council on Drug Strategy which comprises all Australian health and law enforcement ministers.

Acting on a report of a special Task Force which evaluated the first six years of the campaign, the Ministerial Council, which coordinates the work of NCADA, agreed to a continuation of the campaign for a minimum of five years.

As a joint program of all Australian governments, NCADA has operated since 1985 with the aim of minimising harm to the community associated with the use of alcohol and other drugs. To date, NCADA's policies and strategies have resulted in a decline in the use of drugs and their harmful consequence, and in positive trends in public attitudes.

The following are the key components of the program of coordinated initiatives for the 1992-97 national drug strategy in Australia (as approved by the April Ministerial Council meeting):

- National action to reduce the harm caused by the misuse of drugs, including alcohol and tobacco
- Targeting of specific goals and performance indicators to minimise that harm
- Activities to achieve a more harmonious partnership between law enforcement and health agencies
- Establishment of a Drug Crime Prevention Fund to support projects on drug abuse-related law enforcement issues
- More effective community consultation
- Initiatives to meet the needs of special populations, including young people, Aboriginal and Torres Strait Islander people, women, people from non-English speaking backgrounds, injecting drug users and prisoners.

## National Criminal Justice Thesaurus

The 1991 edition of the National Criminal Justice Thesaurus is now available from the National Criminal Justice Research Service. The Thesaurus is used for allocating subject headings in the Major (MA) and Minor (MI) Descriptor fields in the CINCH Database. It is, therefore, an important search for any regular user of CINCH. The Thesaurus is also used for subject terms in the NCJRS Database.
