### Deaths In Custody Monitoring And Research

Following recommendations of the Royal Commission into Aboriginal Deaths in Custody the Deaths in Custody Monitoring and Research Program has been established within the Australian Institute of Criminology, funded by the Commonwealth Government. Its staff are David McDonald, Senior Criminologist; Christine Howlett, Research Officer; and Vicki Dalton, Support Person.

Some of the early work of the Program has involved obtaining, from police and corrections authorities, information on each death in their custody which occurred during 1990 and 1991, using a consistent data collection and analysis framework.

Secondly, negotiations have been initiated with the police, adult and juvenile corrections authorities, and coroners, regarding the consistency of definitions and counting rules concerning deaths in custody. Mechanisms are being established by which the Institute will be informed of custodial deaths as they occur, and will obtain details of coroners' findings on deaths in custody as they become available.

### New Publication Series

A new publication series; *Deaths in Custody, Australia* (ISSN 1038-667X) has been launched by the Institute and the first in the series, *Australian Deaths in Custody 1990 & 1991*, is now available. Future papers in the series will cover a range of related topics. Regular statistical updates on deaths in custody will be produced. Other topics may include information on particular cases and analyses of action taken or required to minimise the incidence of these deaths.

This Database, also available online on DIALOG, includes bibliographic information as well as abstracts on each document, but does not include full-text.

Accompanying the announcement is the welcome decision to make a significant reduction in the price of a subscription. The subscription price of US\$295 will include one CD-ROM with the installation diskette, a manual and a six-month updated CD-ROM. The latest version, current to September 1992, and containing more than 118,000 records will be released on 1 December.
