



Editorial

Together with other members of the Library's staff, I recently attended Information Online & On Disc 93: the Sixth Australasian Conference and Exhibition. The Conference, which is held every two years in Sydney, was heavily over-subscribed and exhibitors at the trade exhibition were overwhelmed with inquiries. I was encouraged to note the interest and enthusiasm for the CD-ROM products demonstrated at the INFORMIT stand at the exhibition. The support for INFORMIT's AUSTROM CD-ROM confirmed the importance for the Institute in having the Library's CINCH Database available on CD-ROM as part of the AUSTROM disc.

At the Conference itself, there were many high quality papers. One highlight was the sessions and papers relating to the role of AARNet and the INTERNET for the academic community, government, and other researchers. There is no doubt that the rapid growth of these services (quoted at the Conference as 10 per cent per month for AARNet and 15 per cent per month for the INTERNET), raises questions, not just about management issues for the networks, but the role of these networks and services for individual agencies. Staff at the Australian Institute of Criminology will follow these developments with interest.

CINCH

The Australian Criminology Database

CINCH, the Australian Criminology Database is a computer-based information system containing bibliographic references to Australian criminal justice subject matter. It is produced by staff of the J.V. Barry Library at the Australian Institute of Criminology.

CINCH is available in a number of forms: online, through the National Library of Australia's OZLINE Service; on CD-ROM as part of the AUSTROM disc; and on diskette for users of PC-based database software. The bimonthly updates of CINCH are also published as part of this *Bulletin*.

Over the year in 1992, 1,672 new records were added to the Database in six separate batched updates. This compares with 1,325 records added in 1991. In total, CINCH now contains 24,199 records.

The diskette version of the CINCH Database contains all records added since the beginning of 1988 or 7,257 records at the end of 1992. The subscription price for this service has remained the same as it was when introduced three years ago. New subscribers pay \$200 for all CINCH records from 1988 up to the present (currently 7,257 records) and \$100 to be

supplied on diskette with the new records at the time that the records are made available to the online host, that is, six batches of records supplied on diskette throughout the year. This diskette service is ideally suited to subscribers using INMAGIC database software. The only restriction on use of this version of the Database is that it should not be disseminated beyond the subscribing agency. OZLINE News

As indicated elsewhere in this issue of the *Bulletin*, CINCH is made available online through the National Library's OZLINE Service. From January, the AGIS Database will be added to OZLINE. AGIS is the Attorney-General's Information Service and is produced by the Lionel Murphy Library at the Commonwealth Attorney-General's Department. It has over 46,000 records and approximately 2,000 records are added each year. AGIS covers all aspects of law and indexes over one hundred Australian, New Zealand, and Pacific law journals as well as selected articles from the major American, Canadian and British law journals.

Users of OZLINE should note that all network centres can access AGIS free-of-charge for one hour during February.

ABS Crime Victims Survey

The Australian Bureau of Statistics has released the results of the second in the *Crime and Safety, New South Wales* series of surveys. The first survey was conducted in 1990. The second was conducted throughout New South Wales in April 1992. The survey covered selected types of household and personal crimes. Household crimes included break and enter, attempted break and enter and motor vehicle theft, while personal crimes included robbery, assault and sexual assault.

The survey itself was a supplement to the ABS Australia-wide *Monthly Population Survey*. It was conducted at the request of the New South Wales Police Service, the New South Wales Bureau of Crime Statistics and Research, and the Department of Court Administration, and was funded by those organisations.

The Survey Publication is available for sale from ABS outlets for \$14 (ABS Cat No. 4509.1; ISSN 1035-9915).

Creating A Safer Community

At the direction of the Commonwealth's Minister for Justice, Senator Michael Tate, the Federal Justice Office of the Commonwealth Attorney-General's Department has prepared and released an issues paper on national approaches to crime prevention.

The paper, entitled *Creating a Safer Community: Crime Prevention and Community Safety Into the 21st Century* has been published for the Federal Justice Office by AGPS (ISBN 0 644 25919 1).

The paper sets out some of the principles which might guide the development of a national crime prevention policy, and suggests some of the major elements and initiatives which could be incorporated into it. Inquiries about the paper should be directed to the Federal Justice Office.

This conference will identify which effective crime prevention strategies could be implemented by Commonwealth, State and Local Government to reduce both the incidence of crime against the elderly and their fear of crime.
- 19-21 April 1993. Criminal Justice Planning and Coordination. Canberra, ACT. Aims of the conference: 1. To examine the interactive nature of independent elements of the criminal justice system to determine the ways in which these elements can operate effectively. 2. To assess the effectiveness of current criminal justice policy and practice.

It is shown that the legal system imposed by the colonial power was inappropriate to Papua New Guinea because it did not fully take account of traditional values and systems of social control, but nevertheless, it had the effect of increasing the status of women within the system of social control and dispute settlement as compared to their status prior to contact. The culture of the four chosen groups is described and the extent to which the colonial powers and the post-independent government took account of the differences between western and traditional approaches to social control is discussed.
