Editorial

This issue of the *Australian Criminology Information Bulletin* contains details of two clearing house initiatives established in the financial year 1992/93. The work of the clearing houses is located at the Australian Institute of Criminology and both have been guaranteed funding for a further twelve months.

The first is the National Clearing House for Information and Research on the Prevention of Child Abuse and Neglect, and the other is the National Clearing House on Violence Against Women.

Later this month I will be representing the Institute at the Second Conference of the World Criminal Justice Library Network to be held at Siracusa, Sicily and I will be reporting on the Conference in a future issue of this Bulletin.

National Clearing House for Information and Research on the Prevention of Child Abuse and Neglect

The National Child Protection Council was established by the Federal Government in 1991. It consists of government representatives from each State and Territory and the Commonwealth, together with five community members with special expertise in various aspects of child abuse and neglect. The Council reports to the Minister for Family Services.

The Council's activities are presently centred on child abuse prevention. It is particularly focussed on primary prevention, which aims to stop abuse before it starts through broad based programs such as media advertising and personal safety programs, and secondary prevention, which aims at early intervention in high risk vulnerable groups.

In all of its activities the Council takes into account the special child protection needs of children

from non-English speaking backgrounds, children with physical disabilities, developmentally delayed children, and Aboriginal and Torres Islander children. The Council funds the Secretariat for National Aboriginal and Torres Islander Child Care, which is preparing a plan of action for the prevention of child abuse and neglect within those communities.

The Council has commissioned the Australian Institute of Criminology to host a National Clearing House for Information and Research on the Prevention of Child Abuse and Neglect. The Clearing House will:

- collect published materials on child abuse and neglect and its prevention, and incorporate them within the collection of the Institute's J.V. Barry Library;
- make potential users aware of the material through CINCH, the Australian Criminology Database, and also through the Australian Bibliographic Network (ABN), the national shared cataloguing system;
- provide clients with advice on prevention programs and research, both in Australia and overseas;
- disseminate information about the Clearing House and its holdings in a regular newsletter and through other publications as the need arises.

National Clearing House on Violence Against Women

In early January 1993, the National Committee on Violence Against Women (NCVAW) in conjunction with the Australian Institute of Criminology, initiated the development of a database of programs, projects and research in the area of violence against women. This six month project was to be the first step towards establishing a national clearing house of information on violence against women.

The objective of the database is to record details of recent community activities, programs and projects that are being conducted throughout Australia, current and past research, and government policies and activities which aim to reduce violence against women. The information contained in the database will be made available through the clearing house to assist other groups in their work.

The establishment of a database will encourage all those working in the area of violence against women to share their experience, expertise and knowledge.

A questionnaire has been piloted which seeks relevant information from individuals and organisations. The feedback from this pilot will be used to guide the development of a national survey of relevant organisations which are involved in programs, projects and research relating to violence against women. The national survey will be conducted following analysis of data obtained from the pilot and revision of the questionnaire's format.

The final aim is to build a comprehensive picture of the ways in which governments and the community sector are responding to the issue of violence against women.

All government and non-government organisations currently engaged in programs, projects and research related to violence against women are invited to contribute to the national database.
