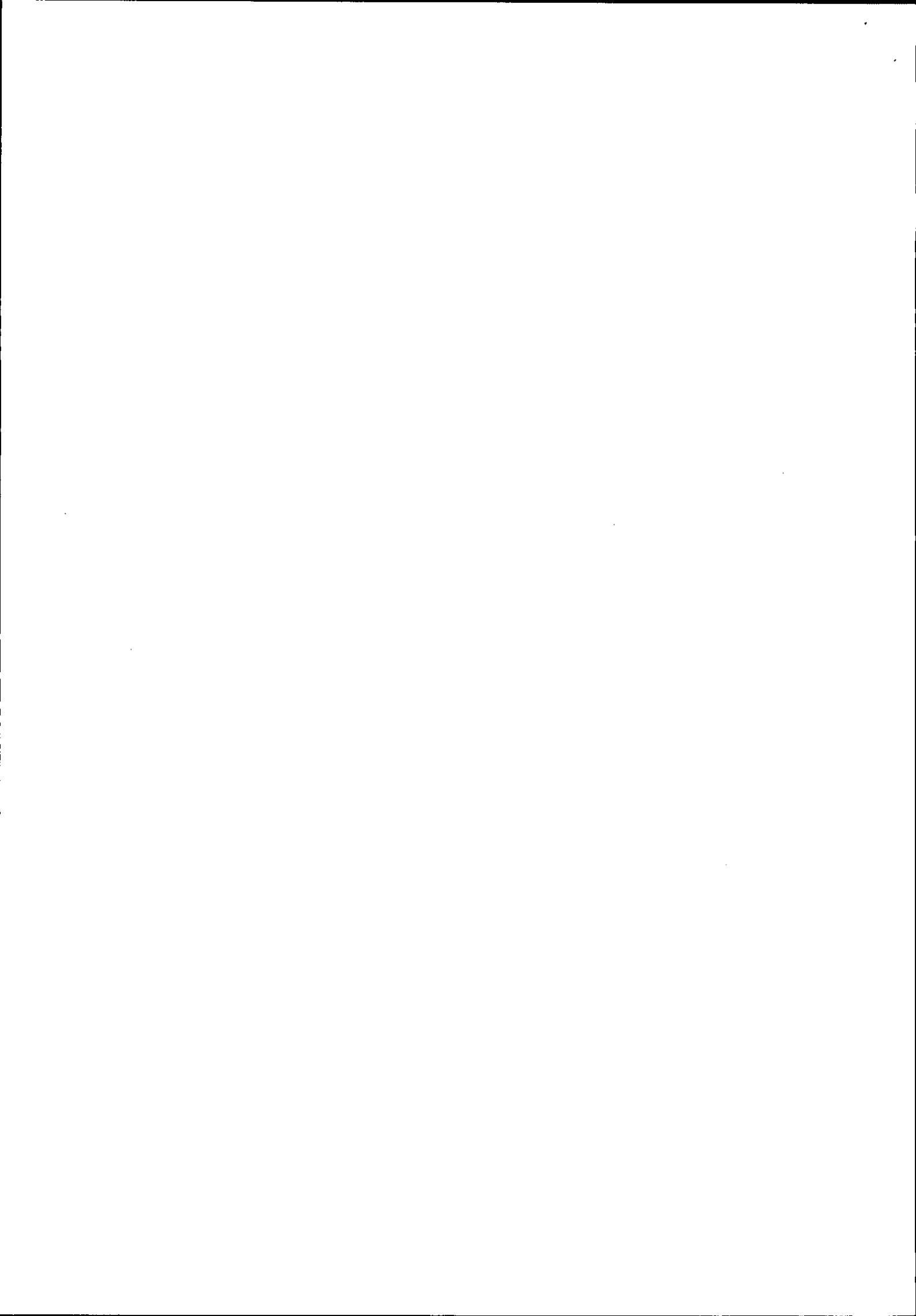

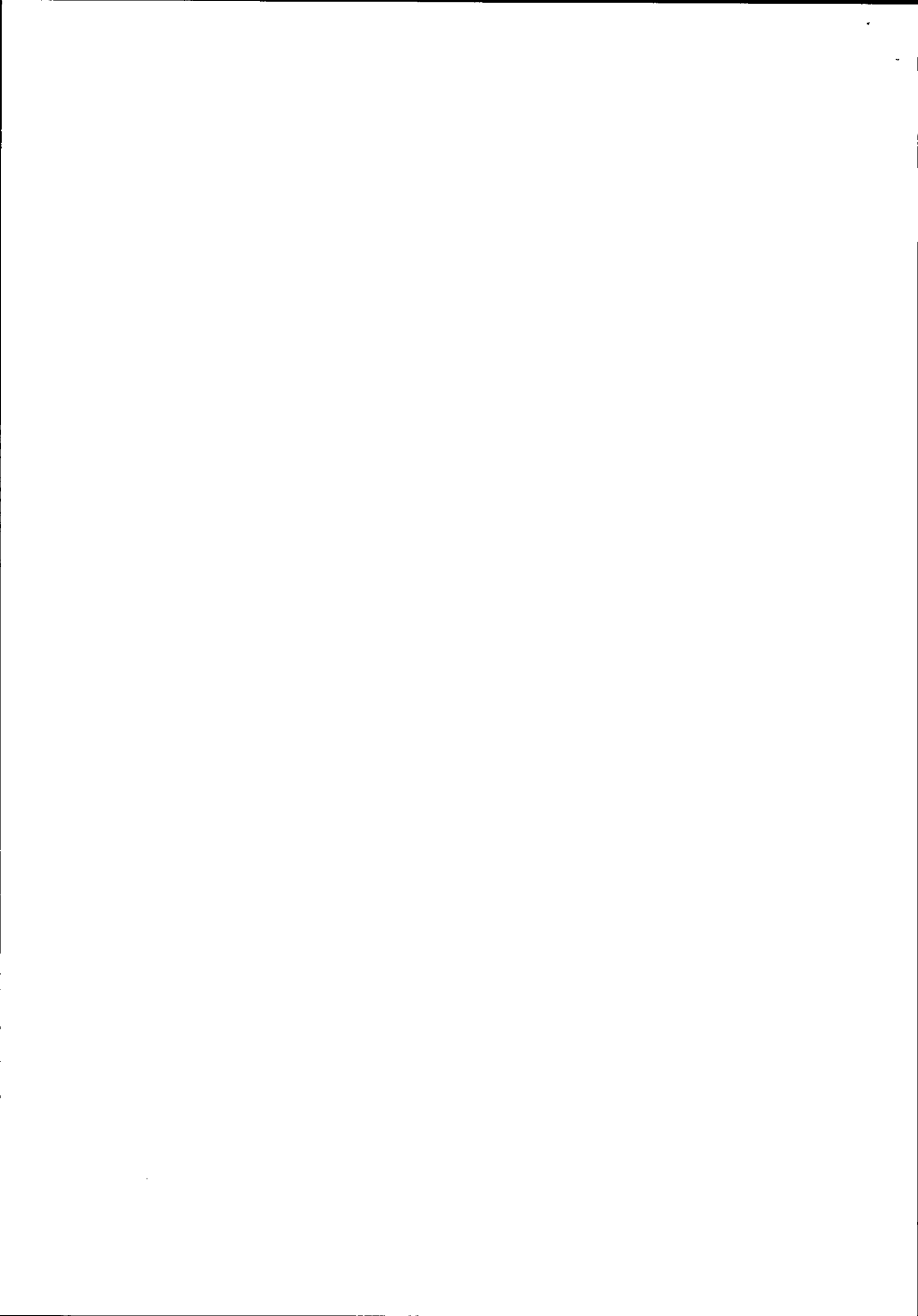

The Origin and Content of Professional Practice in Corrective Services

Kenneth Bradshaw

A clear and comprehensive overview of significant changes occurring in one of the key components of the criminal justice system. Written by Queensland Corrective Services Commission Metropolitan Regional Manager Kenneth Bradshaw, the paper charts the shift in corrective services from a narrow concern with incarceration and punishment to a broader program of rehabilitation and community corrections. The changing role of corrections officers is also analysed, covering the diversity of tasks and skills required of modern correctional personnel.

Safe as Houses: Proceedings of the first Griffith University Workshop on Crime Prevention Through Environmental Design

Edited by W. Sarkissian, C. Whitzman, L. Rosier and J. Llewellyn

This is the published report of the Centre's CPTED workshop held in December 1991. The Key speaker at the workshop was Wendy Sarkissian, Director of Sarkissian Associates Planners. An expanded version of Wendy's presentation is provided in this paper covering principles of environmental crime prevention with a focus on design principles for medium-density housing. Other contributions include a report on women's safety initiatives in Toronto, Canada, the Women's Safety Project in Brisbane and a review of theoretical and practical issues in CPTED.

Women in Policing: Policy Implications from the US Experience

Tim Prenzler

Examines the issue of women's involvement in policing. The United States has been a leader in opening police work to women and in charting that expansion by innovative research. This paper is the result of two months study in the US by Centre member Dr Tim Prenzler. The paper provides an update on the American situation with an analysis of research findings applicable to Australia.

A Framework for Evaluating Community-based Juvenile Crime Prevention Programs

G. Murray, R. Homel, K. Wimhurst, T. Prenzler, and I. O'Connor

Designed in response to government support for community development projects oriented to crime prevention and the consequent need for accountability. The paper is a comprehensive guide to evaluation and includes a model for process and impact evaluation, guidelines for developing performance indicators and an outcomes hierarchy, a data collection schedule, and a description of data collection instruments.

The guide was developed with user friendly qualities firmly in mind. Given that programs will vary greatly in their target groups and activities, emphasis is placed on generating a model that could be readily adapted to different programs. Recognition is also made of the complex causes of juvenile offending and the possible limitations of government-sponsored interventions. With this in mind the centrepiece of the guide is an outcomes hierarchy which can be used to assess different levels of achievement of project objectives.
