A reminder that apart from CD-ROM, CINCH is also available online as part of the National Library of Australia's OZLINE Service. In addition, all CINCH records from 1988+ are available on subscription for users of PC-based database software, such as INMAGIC. The 1994 subscription is \$250 for all records from 1988 up to the present (currently 9,130 records) plus \$150 for the six bimonthly updates as they become available in 1994.

The CINCH Database

CINCH, the Australian Criminology Database is available on CD-ROM as part of the AUSTROM disc. The most recent version of AUSTROM (Volume 4 Number 2) contains a number of new features which offer greater flexibility in searching the CINCH Database. These features include

- A Date field. This allows searches to be limited within a range of years of publication. For instance, a search on *Organized Crime* in the Major Descriptor field can be limited to all documents with a year of publication more recent than, say, 1991.

Child Protection Projects

The Australian Institute of Health and Welfare's Child and Family Support Unit is currently undertaking two major child protection projects - the preparation of the publication *Child Abuse and Neglect 1991-92*, which is reaching the final stages, and the compilation of a compendium of Australia's child protection systems.

This latter project, currently referred to as the *Child Abuse and Neglect Source Book*, will include for each State and Territory, a description of the child protection system, references to legislation, a summary of the mandatory reporting position, a glossary of terms, and a list of the major government and non-government organisations with a role in child protection.

The first version of the *Sourcebook*, which will be produced in loose-leaf form, is expected to be available around mid-1994. As the project is presently at the developmental stage, the Australian Institute of Health and Welfare would welcome any comments on the content or layout of the *Sourcebook*.
