Editorial

As this issue of the *Australian Criminology Information Bulletin* reports, the past two months have involved considerable changes for the Australian Institute of Criminology.

In April the Minister for Justice announced a review of the Institute under the chairmanship of Mr Noel Tanzer. Following the announcement, the Institute cancelled the Ninth Conference for Librarians in the Criminal Justice System, which had been scheduled to be held in Canberra from May 11 to 13.

I would like to apologise for any inconvenience resulting from the cancellation. Because of the need for Library staff to be committed to the review, I was not able to justify the staff time required for organising and attending the conference.

In the past this series of conferences has represented an important part of the Library's work program. However, Australian criminal justice librarians now have a variety of alternative means of meeting and consulting and I do not anticipate that the Institute will be involved in organising any more library conferences.

In spite of the changes that the Institute is experiencing, and without in any way attempting to anticipate the results of the review process, I am confident that the Institute's Library will continue to be involved in the dissemination of criminal justice information and the provision of library services.

Changes at the Australian Institute of Criminology

In April this year, following the release of the report of the Review of Commonwealth Law Enforcement Arrangements, the Institute commenced a further review under the chairmanship of Mr Noel Tanzer. This review will be reporting to the Commonwealth Government by the end of May.

Following announcement of the review the Institute's Director, Prof Duncan Chappell, resigned to be replaced by Dr Grant Wardlaw as Acting Director for a period of six months. Prior to his appointment, Dr Wardlaw was a consultant with the Federal Justice Office and had previously been a senior member of the research staff at the Australian Institute of Criminology.

Accompanying the Review is a restructuring of the Institute's operations which will include a reduction of the Institute's budget for 1994/95 and a significant reduction in the overall staffing level. Because of the work involved in restructuring, for the period up to June 30, the J V Barry Library should be treated as a library of last resort for inter-library loans.
