Editorial

Two weeks ago INFORMIT released vol. 5 no. 1 of the AUSTROM CD-ROM.

Readers will be aware that AUSTROM, first released in 1990, contains a number of major Australian bibliographic databases covering the social sciences, education and the law. The Institute's CINCH database has been part of AUSTROM since its inception.

As four years have passed since the release of the initial AUSTROM disc, it is interesting to reflect on its impact for libraries, researchers, and database users. For the database producers represented on AUSTROM, having their databases published on this CD-ROM has presented them with a far wider market than had ever previously been conceived. The wide acceptance of AUSTROM by Australian libraries has also meant that for the first time the different database producers would receive a significant royalty return from their databases. For all those involved, it has certainly been an interesting four years.

CINCH

Effective from the 9403 update of the CINCH database, the database records will include ISSN information for any journal or serial publication that is being indexed. This change has been introduced to facilitate inter-library loans and document delivery for libraries.

The information will be found in the ISBN (IS) paragraph and the prefix ISSN will also be included, unlike the ISBN of a monograph, when only the number is entered in this field. An ISSN will appear in the following form:

OZLINE

1. New Databases

Apart from the range of AUSTRALIS databases added to OZLINE in the past month, two other databases have recently been added to OZLINE.

The FAMILY full text database (FAMT) became available for use from 4 July. The database is produced by the Australian Institute of Family Studies. It consists of almost 300 records containing the full text of some of the journal articles and conference papers which are indexed in the existing OZLINE database, FAMILY (Family and Society Abstracts). A note in the FAMILY database record directs users to the full text document. All documents are copyright, either to the Australian Institute of Family Studies, or as stated in the full text record.

The ARCH database was added to OZLINE in June. The database is produced by Stanton Library in North Sydney. It contains records indexed from Australian and New Zealand architectural, building and allied journals held by that Library. The database is updated six times per year and currently contains over 13,000 records.

2. Armed Robbery

The Institute's J V Barry Library has received a copy of a new research paper, *Armed Robbery : a Study in London*, co-authored by Shona Morrison and Ian O'Donnell. Shona is currently employed as a researcher at the Australian Institute of Criminology's National Deaths in Custody Monitoring and Research Unit.

The paper reports the first survey of serious armed robbery in London to be published for over 25 years. Using data collected from police records and in-depth interviews with incarcerated armed robbers, it explores the nature and dynamics of armed robbery.
