2. Cleartalk Report

There are two levels at which police can respond to the communication needs of people with an

intellectual disability. The first is to recognise the basic needs of all people in situations which depend on clear communication. The second is to acknowledge the adaptations necessary in individual cases to ensure that these common needs are met.

Dr Mark Brennan from Charles Sturt University's School of Education, together with Research Officer Roslin Brennan, have researched and produced support materials for police. Titled 'Cleartalk', the materials consisting of policy, training and publicity documents, have been developed through the process of collating police attitudes and ideas about communicating with people with intellectual disability.
