There are two reasons for discontinuing this publication. Firstly, recent cuts to the Institute's staff and budget mean less staff time for such activities. In addition, the CINCH database is now widely available electronically; either as part of INFORMIT's AUSTROM CD-ROM or online through the National Library's OZLINE service.

The conferences information and news items will be available in the Institute's quarterly journal, *Criminology Australia*, and it is therefore an excellent time to become a subscriber.

CINCH, the Australian Criminology Database

Arrangements for the production and supply of the CINCH database have been changed and will result in an improved service for users of the Database.

Effective from the beginning of 1995, the Australian Institute of Criminology is contracting

out all CINCH indexing. Institute staff will remain responsible for the overall management of the database, and for delivery of updates and corrections files to the National Library for OZLINE.

It is anticipated that more than 3,000 records will be added to CINCH during the coming year, considerably more than in previous years. Because of the increase, CINCH on OZLINE will be updated more frequently; ten updates in 1995, compared with six in previous years. The first update will be delivered by the end of February and will continue each month, with the final update for 1995 by the end of November.

The other significant change is that for the first time, new CINCH records will all have a short abstract. Although the CINCH database has had an abstract field in its data structure, until now this field has been used more for notes, rather than for formal abstracts.

In summary, these are the changes for CINCH:

- More than 3,000 records to be added in 1995;
- 10 updates during the year for CINCH on OZLINE, commencing at the end of February, through to November;
- All new records to have abstracts.

OZLINE

1. New Database

A new criminal justice database is now available on OZLINE. AFPD, or Australian Federal Police Digest, is produced by the AFP's Library in Canberra. The Database aims to support the information need of people working in the area of Federal law enforcement and community policing. It also aims to provide a valuable information resource to the broader community.

AFPD covers:

- police operations
- management issues
- training
- other disciplines related to modern policing

The Database has approximately 3,000 records and will be updated four times per year. It commenced in 1991 and selectively indexes articles from Australian and overseas journals, individual chapters from books, as well as conference papers. As a new OZLINE database, it is available free for February.

2. Free Time on OZLINE

As well as having free access to AFPD for February, a reminder to searchers that a selection of OZLINE's databases are being offered free-of-charge each month during 1995. The schedule of free offerings is regularly advertised in *ABN with OZLINE News*.

NCJRS Microfiche

Margaret McPherson, Executive Director of Library Services at Charles Sturt University, has advised that CSU Library has now received a complete set of National Criminal Justice Reference Services (US) microfiche.

The collection comprises 33,696 documents for the period 1972-1992 and is supplemented annually. It allows immediate access to primary sources of information in such important areas as law enforcement, the administration of justice, juvenile justice, and crime prevention.

The purchase has been made possible by an allocation from the University's Teaching and Research Infrastructure Equipment Fund to the Faculty of Arts. This recognises the growing importance of police studies within the Charles Sturt University course profile.

The Library will provide access to the fiche on campus at Bathurst, or by fiche copy. Inter-library loan request will be welcome, subject only to any restrictions placed by the supplier.

The NCJRS Document Data Base on CD-ROM indexes this collection as well as books, journal articles, grants and evaluations in the criminal justice area.

New CD-ROM

A new CD-ROM, *Australian Family Resources on CD-ROM*, has been published by the Australian Institute of Family Studies, in association with the Royal Melbourne Institute of Technology.

The Australian Institute of Family Studies has gathered together a collection of resource documents from a number of key Australian organisations working to support children and families. The documents are included on the CD-ROM as scanned images and can be retrieved by searching bibliographic records from the *Australian Family and Society Abstracts* (FAMILY) database.
