New AIC Chairman launches online Library catalogue

lients from around the world are now able to search the Australian Institute of Criminology's J V Barry Library catalogue online via the Internet. In launching the new facility from the AIC offices in Canberra on Wednesday 29 July, Professor Richard Fox, new Chair of the AIC Board of Management, spoke of the importance of the Library to the Institute and to the worldwide justice community:

"From the inception of the Australian Institute of Criminology, 25 years ago, it was understood that a research and reference library was central to its functions. The foundations of this library consisted of the large personal library of the late Sir John Barry, Judge of the Supreme Court, Victoria and Chairman of the Board of Studies of the Department of Criminology, Melbourne University, who had always been an advocate for the establishment of a national institute such as ours. It is proper that the Library continues to bear his name.

"... Sir John Barry would have been as delighted as he would have been amazed at the capacity of a web page on the Internet to provide access to Australia's premier criminological library to anyone seeking information, not merely from within Australia, but from anywhere in the world.

"Having the Library's catalogue available online as part of the Institute's web site [http://www.aic.gov.au] extends the range of individuals, libraries and organisations which will be able to search the holdings of the J V Barry Library. Not only

will clients be able to search the catalogue via the Internet using the conventional forms of inquiry, they will also be able to set up subject profiles so that they will be alerted to new literature of interest. This current awareness service complements the CINCH database which is generated by the Library as an index of Australian criminal justice subject matter."

Professor Richard Fox congratulated the members of the Library on this significant improvement in Library services.

Note: The appointment of Professor Fox as Chair of the AIC Board of Management was announced by the Minister for Justice, Senator Amanda Vanstone in late May. Professor Fox is Professor of Law at Monash University, where he has held various positions since 1972. He was in Canberra to chair his first AIC board meeting on 30 July 1998.

Commercial Sexual Exploitation of Children in Australia: New Research Project

The AIC has been commissioned by the Commonwealth Department of Health and Family Services to produce a national stock take of legislation and policy relating to the commercial sexual exploitation of children in Australia. The project, undertaken by Dr Peter Grabosky and Research Analyst Anna Grant,

in collaboration with AIC Associate, Senior Lecturer in Law, Simon Bronitt and Ms Fiona David, is investigating child prostitution, the abduction and trafficking in children, and child pornography. Results of the research are expected to be the basis for Australia's national action plan, pursuant to Australia's becoming a signatory to the Declaration following the World Conference on the Commercial Sexual Exploitation of Children, held in Stockholm in 1996. The current project follows earlier work at the AIC relating to sexual offences against children, and crime involving use of the Internet.

3rd National Outlook Symposium

■ lanning for the AIC's 3rd Tational Outlook Symposium on Crime in Australia, to be held in Canberra from 22 to 23 March 1999, is well advanced and it is shaping up to be one of the most exciting yet in the field of crime and criminal justice in Australia. The subtitle "Mapping the Boundaries" sets the theme with plenary sessions such as "Boundaries within the Criminal Justice System", "Commonwealth/ State Boundaries", "Boundaries between Public and Private" and "Transcending Boundaries". Concurrent sessions (20 over two days) look at topics such as drugs and crime, juvenile justice, ethnicity and crime, law enforcement and Indigenous Australians, restorative justice, interjurisdictional differences in crime rates, deaths in custody, firearms, fraud, homicide, sentencing patterns and trends, policing, corrections, remand, violence, preventing violence and crime, markets for stolen goods and domestic violence.

This Symposium will showcase the work of the Australian Institute of Criminology with all research staff involved in the planning and implementation of the program. AIC Staff in Asia

The 12th International Congress on Criminology is being held in Seoul, Korea in August 1998. The AIC will be well represented with both the Director and the Director of Research addressing the Congress.

The International Society for Criminology was founded in 1938. The ISC has a consultative status with the United Nations and the Council of Europe. The primary purpose of the ISC is to promote actions and research that will foster a better understanding of criminal phenomena at the international level. This 12th Congress is the first to be held in Asia. The main theme of the Conference is "Crime and Justice in a Changing World: Asian and Global Perspectives".

On his return journey from Korea, the Director will be giving two papers in Singapore: the first to be given at the National University of Singapore on Crime and Public Policy and the second to a legal forum on juvenile justice.

The AIC has been invited to submit a paper on "Payment Card Fraud Prevention" for the International Symposium on the Prevention and Control of Financial Fraud to be held at the China University of Political Science and Law to be held in Bejing from 19 to 22 October.

In June, study tours by the Supreme People's Procuratorate and the Ministry of Justice of the People's Republic of China introduced senior Chinese justice officials to the Australian legal system. As part of these tours, both parties visited the AIC on 9 June to discuss with AIC staff the work of the Institute. In early September, the Assistant Research Fellow, Li Xiancui, of the Institute of Public Security of the People's Republic of China will be visiting the AIC and during this time will give an occasional seminar on "Policing in China".
