

PREFACE

Police and police related materials and information services have been something of a growth area in recent years. Concurrent with this expansion of materials and services has been a marked increase in the number of persons requiring access to them.

Only a few years ago, a relatively small number of policepersons and academics were the almost sole users of and contributors to the police resources discussed here. Now, numerous policepersons, security specialists, criminologists, criminal justice professionals, planners and policymakers, students and, above all, researchers, are engaged in the field.

Some of these people, particularly those new to the field, require assistance concerning not only those materials and services exclusive to police (or, more accurately, criminal justice agencies) but, also to publicly available information sources and services.

This Guide is an attempt to provide that assistance.

Whilst every effort has been made to make this a useful and convenient tool for researchers, within the production policies applying, it is accepted that perfection is a never achieved ideal. Thus, users identifying errors and/or omissions, or having suggestions for improved format, etc, are respectfully requested to contact this Institute with a view to having future editions amended.

GLOSSARY OF TERMS USED*

Microreproduction - A reproduction produced photographically or by other means on either transparent or opaque materials in a size too small to be read by the unaided eye. Also called microform.

Monograph - A work, collection, or other writing that is not a serial.

Monograph in series - A number of separate works issued in succession and related to one another by the fact that each bears a collective title generally appearing at the head of the title page, or the half-title, or on the cover; normally issued by the same publisher in a uniform style, frequently in a numerical sequence.

Periodical - A serial appearing or intended to appear indefinitely at regular or stated intervals, generally more frequently than annually, each issue of which normally contains separate articles, stories or other writings. Newspapers disseminating general news, and the proceedings, papers, or other publications of corporate bodies primarily related to their meetings are not included in this term.

Serial - A publication issued in successive parts bearing numerical or chronological designations and intended to be continued indefinitely. Serials include periodical, newspapers, annuals (reports, yearbooks, *etc*, of societies), and numbered monographic series.

INTRODUCTION

This Checklist/Guide is intended as a practical, ready reference to be used in the workplace by police researchers in pursuit of materials and/or information. As such, it will save the researcher's time at the expense of understanding.

For example, readers requiring a parliamentary paper pertaining to police are not given an account of how parliamentary papers are catalogued. Instead, an annex is provided listing all such papers.* Valuable time is thus saved, albeit at the expense of understanding the organisation of the wider literature.

A researcher's rather than a librarian's perspective is adopted in discussing and conceptualising the field. Thus, distinctions are made between direct and indirect sources and police and non-police sources.

The primary aims of this Guide are to acquaint police researchers with materials and information services which are:

- a. specific to police, and
- b. not specific to police but, which are nonetheless important to the performance of their research tasks.

PART I - MATERIALS

Materials relating to police and likely to be of utility to researchers are primarily in printed form. Printed materials fall into one or other of two broad categories: (1) serials, (2) monographs.

Nonprinted materials, which are relatively limited, are available in audio, video, film, and microform formats.

These categories are briefly dealt with in turn. Actual materials are listed in the various Annexes as indicated.

PRINTED MATERIALS

Serials

Serials are those publications which are published in series, either regularly or irregularly. For present purposes they are divided into the following categories:

- a. journals,
- b. periodic reports, *eg*, annual reports,
- c. abstracting and indexing journals, and
- d. all other printed material published in successive parts as an ongoing process.

Journals are a major source of information concerning police. They range from publications such as the *Journal of Police Science and Administration* through newsletters and bulletins. A list of Australian journals likely to be of assistance to persons seeking material concerning police and police related activities is given at Annex A. A list of foreign journals and serials is given at Annex B.

Periodic reports, such as departmental annual reports, are particularly valuable sources of raw data to researchers. A list of useful Australian periodic reports is given at Annex C.

Abstracting and indexing journals are probably the most important of all guides to the police literature. A list of such publications is given at Annex D.

Other printed material published in successive parts is a miscellaneous category including material as diverse as research reports produced by the NSW Bureau of Crime Statistics and Research and, the proceedings of the Institute of Criminology at Sydney University. A list of such materials is given at Annex E.

Monographs

Monographs are essentially those publications not defined as serials. For present purposes they are divided into the following categories:

- a. books,
- b. reports,
- c. pamphlets,
- d. theses,
- e. monographs in series, and
- f. unpublished papers,
- g. reference books, *ie*, dictionaries, handbooks, encyclopedias.

Books are, for present purposes, considered to be publications not otherwise defined and as being of sufficient substance to constitute a single volume, *ie*, in excess of 50 pages. Books vary greatly in nature; some being highly specific, others completely general. Some books confine themselves to a single subject or theme, however loosely defined. Others, *eg*, some anthologies, may deal with a wide range of matters.

Worldwide, the number of books wholly or partly, directly or indirectly, concerning police is great. Indeed, the number is so great it is not possible to attempt a listing in this Guide. However, the Australian literature is not large and a list of books is attached at Annex F.

Reports cover an extremely wide range of material produced by a variety of sources. All the more significant Australian reports, *eg*, royal commission reports and administrative reports, possessing relevance to police are listed at Annex G. The great majority of these reports are published as parliamentary papers.

Pamphlets range from what are in effect one page tracts through to substantial publications verging on the status of a book. They are normally confined to a single subject or topic. A list of pamphlets of relevance to

police is given at Annex H .

Theses are a distinct and clearly identifiable category. They normally consist of research dissertations submitted in part fulfillment of the requirements of a graduate diploma or, an honors', masters' or, doctoral degree. A list of Australian theses of relevance to police is given at Annex I . A separate list of reports submitted by Winston Churchill Trust Fellows on police related topics is included at Appendix 1 to this Annex.

Unpublished papers are usually confined to specific topics, often for special occasions, *eg*, conferences and seminars. Sometimes researchers and theorists will write a paper in order to clarify their own ideas on a subject prior to commencing research. Quite often such papers are circulated amongst a select list of colleagues for criticism. Many papers of this type are most valuable. The problem is, because they are unpublished they are not always known and thus difficult to procure. It is for this reason that a list of unpublished papers is not attempted in this Guide. Researchers are well advised to develop a knowledge of such papers in their areas of particular interest.

Reference books such as dictionaries and encyclopedias are extremely useful tools for researchers. A list of the more important reference books for police researchers is given at Annex Q .

NONPRINTED MATERIALS

Audio

Relatively little audio taped (including cassette) material concerning police or police related matters, excluding actual police training material, is available. The IACP distributed the Agenda Series of tapes but, no longer does so.

Video

Videotaped material either of concern to police or related thereto is in equally short supply. In view of the paucity of available material a list is not provided.

Film

Numerous films are available concerning or related to police, mostly of a training nature. Commercial distributors rent and sell such films. ANL loans a limited number of films on request at no charge.

Microreproduction

Microreproduced materials likely to be of interest to those in search of police materials include:

- a. microfilm,
- b. microfiche, and
- c. microcard.

Microfilm is being increasingly used by libraries and, other private and public organisations possessing substantial printed records. Microfilm, a miniature photographic negative, is used as a replacement for the printed product. For instance, some State libraries microfilm their newspaper holdings. Researchers are required to scan the microfilm rather than the original hard copy thus saving a great deal of wear and tear on irreplaceable items. At the same time, researchers are subjected to an uncomfortable and inconvenient experience whilst searching microfilm products.

Microfiche is a greatly reduced negative in the form of a single sheet, similar to frames on a microfilm. As many as 98 microcopies can be contained on a single sheet. As with microfilm, it requires to be scanned on a specially designed and illuminated display unit.

Microcard is an opaque product upon which miniaturised images are photographically reproduced. They can be read with the aid of a magnifying glass.

PART II - INFORMATION SOURCES AND SERVICES

Researchers and others in search of published information need either to obtain their data directly, *ie*, at source, or, indirectly, *ie*, by means of an information service. Indeed, researchers' chances of ultimate success are very much determined by the thoroughness with which these two avenues are explored. For professional researchers, a detailed knowledge of relevant sources and services, and what they can offer, is most important.

SOURCES

Institutions which store published (and other) data are basically of three types:

- a. originating institutions, *eg*, police departments,
- b. libraries, and
- c. archives.

The first category is self evident. Only the latter two are discussed here.

Libraries

Libraries, despite their many shared functions, are of several quite distinct types. They are classified here as:

- a. university libraries,
- b. State and National libraries,
- c. specialist libraries, and
- d. government department libraries, including police libraries.

University libraries are located at all universities. In fact, most universities possess a number of separate libraries. Colleges of Advanced Education and Institutes of Technology are included in this category. Some university libraries are specialised, *eg*, law, medicine, biological

sciences, whereas others are of a general nature, *eg*, undergraduate and main libraries.

As a general rule, persons not accredited with universities are not permitted to borrow from university libraries. In some cases, special permission is required to even read material within the library building. Researchers and others not accredited with a university, but desirous of utilising its library resources, should ascertain local requirements. A comprehensive list of tertiary education institutions in Australia is provided at Annex J. Inquiries may be addressed to the head librarian in any given institution in the first instance.

State and National libraries are reference libraries, *ie*, material has to be perused on site. Loans of reference materials, where permissible, are almost entirely restricted to other libraries, *ie*, inter-library loans. Photocopying and/or microfilming facilities are now universally available in these libraries.

State and National libraries represent an invaluable resource to all researchers.

Specialist libraries include a mixed bag of both public and private libraries, some of which cater to out-of-house clients and others which are either exclusively or largely designed to support in-house requirements. Examples of specialist libraries are:

- a. Supreme Court libraries,
- b. Law Reform Commission libraries,
- c. CSIRO libraries,
- d. newspaper libraries,
- e. Victorian Historical Society library, and
- f. Australian Institute of Criminology library.

Libraries maintained in Australia by the US Information Service and the UK High Commission are included under this heading as a matter of convenience.

Government department libraries are those libraries maintained by government departments to support the functions of the host organisation, *eg*, police department, or attorney general's department. Like universities, government departments sometimes possess more than one library.

Several specialist and public service libraries in the criminal justice field, (including police) have formed their

own conference, which meets biennially. These libraries operate in support of each other, thereby providing an improved service to police researchers. A list of participating libraries is provided at Annex. K

Archives are maintained in one form or another by both federal and State governments.

Australian Archives attend to federal and territorial archival needs. In New South Wales, the Archives Office is the appropriate authority concerning archival matters. In Victoria, a similar function is performed by the Public Records Office. In all other States, archive functions are performed under the authority of the State Librarian.

The cities of Sydney and Adelaide have both appointed their own archivists and certain universities, *eg*, Sydney, ANU, Melbourne and Wollongong have commenced archiving materials. The latter three mentioned, in addition to archiving their own records, are also archiving certain business and union records.

For researchers interested in learning more about archives, their locations are referred to the appropriate literature.* At the time of writing, the Australian Society of Archivists is preparing a comprehensive directory of archives and archival facilities.

Files and other materials stored by the various archival authorities are subject to a variety of access classifications. Researchers need to acquaint themselves with the regulations applying in pertinent jurisdictions.

Source materials

Materials capable of providing researchers with needed data are many and varied. The vast majority of these materials are available in libraries, although only the largest possess them all.

Source materials are of two kinds, those which:

- a. contain data, and
- b. list sources of data.

In other words, there are direct and indirect sources. They are discussed here in that order.

Direct sources of interest to police researchers are quite varied. They consist mainly of data compilations that may appear once only or, which are repeated annually. Encyclopedias and inventories, as well as specialist dictionaries, are also included in their number. They are referenced at Annex Q.

Indirect sources include the following categories:

- a. directories,
- b. bibliographies,
- c. abstracts,
- d. indexes, and
- e. guides.

Certain indirect sources overlap category boundaries and are thus difficult to classify. In some cases, arbitrary selection becomes necessary.

Directories are listings which itemise such things as persons, organisations, and locations. A number of useful directories are listed at Annex L. A directory of Australian police forces and unions is given at Annex R.

Bibliographies are listings of materials. They may be annotated. A number of general bibliographies of utility to researchers are listed at Annex N.

The number of subject specific bibliographies is vast and, even if they were all known, could not be listed here. In Australia, the library of the Australian Institute of Criminology specialises in bibliography compilation performed by both its CINCH service and its reference staff. See Annex P.

Elsewhere, the National Institute of Law Enforcement and Criminal Justice has produced a large number of annotated bibliographies of utility to police researchers, as has also the Federal Bureau of Investigation. The former organisation prepares bibliographies on request.

Other institutions significantly concerned with the production of bibliographies are the library of the Centre of Criminology at the University of Toronto, Canada and, the library of the Institute of Criminology at Cambridge University, England.

Abstracts and indexes are, as previously stated, some of the most important of all sources of information. They

both serve roughly the same function but, abstracts tend to be more informative by virtue of their annotation. Lists of both sources, direct and indirect, are shown at Annex D.

Guides to the criminological and police literature are not numerous. Sometimes it is difficult to distinguish guides from bibliographies and indexes. However, it is possible to do so with a little forcing and some of the better guides available are listed at Annex O.

SERVICES

A number of information services are available to researchers in Australia and overseas. Some are quite general in nature whilst others are restricted to criminal justice matters only.

Information services can be classified as belonging to one or other of two major groups:

- a. current awareness services, and
- b. general bibliographical and information services.

Current awareness services in Australia

Current awareness services, as the term implies, are designed to keep users abreast of current publications, and/or research, and/or events. Such services are provided either by established libraries or by other organisations possessing a defined information role.

Australian libraries providing current awareness services of possible utility to police researchers include:

- a. National Library of Australia,
- b. JV Barry Memorial Library,
- c. South Australian police library, and
- d. Victoria police library.

The National Library of Australia provides several important current awareness services of utility to police researchers. These include:

- a. SSCIS,
- b. MEDLARS,

c. AUSINET, and

d. ANSOL current awareness bulletins.

SSCIS has a data base derived from nearly 4,000 journals in the social sciences field. It is issued weekly on magnetic tape. Tapes are searched in accordance with user interest profiles. Card printouts are provided users approximately weekly. Users are limited to a select number of libraries.

Fees (at the time of writing) are \$75 pa. Retrospective searches on demand are charged at the rate of \$20 each.

MEDLARS operates in a manner similar to SSCIS but derives its data base from medical and paramedical publications. It is useful in relation to subjects such as police health and job satisfaction.

AUSINET consists of a consortium of libraries coordinated by ANL. Each member library places its data base on disc with Australian Consolidated Industries in Melbourne. Discs are accessible by all contributing libraries. It is expected that during the 1978-79 financial year AUSINET will be interfaced with the Lockheed Information Retrieval Service in California, thereby making available to researchers, almost immediately, an immense, additional range of data sources.

ANSOL current awareness bulletins are current awareness publications issued by the National Library. They are derived from SSCIS tapes. Bulletins are produced under titles such as "criminology" and "violence". They are available to libraries at a cost of \$10 pa per title for 12 issues.

Photocopies of articles cited therein, if not otherwise available, may be obtained on inter-library loan only at a cost of \$1 per item, with an extra charge of \$1 for each additional 10 pages, or part thereof, from the same item.

Current awareness services outside Australia

Both Canada and America possess current awareness services which may be of utility to Australian researchers.

CAN/SDI current awareness program is operated by a consortium of five government libraries in Ottawa. Data bases are placed on magnetic tape. User interest profiles are compiled in the normal way and searched accordingly. Printout items are frequently annotated.

CISTI also operates a program known as CAN/OLE. This service permits on-line searches, both retrospective and current. Fees vary according to the nature of the tapes accessed. The service is nationwide and has been available since 1974.

Abstracting services utilised in the compilation of CAN/OLE include COMPENDEX and INSPEC. The *Union List of Scientific Serials in Canadian Libraries* is similarly incorporated.

The US National Criminal Justice Reference Service (NCJRS) is in fact an international clearing house for criminal justice information. It provides a range of services to researchers in relevant fields. Services other than current awareness are dealt with in succeeding pages.

Any individual, agency, or organisation may register for NCJRS services all of which are free. Selected current awareness notifications of materials and events are despatched to users monthly.

Since 12 September 1977, the NCJRS has been operated by Aspen Systems Corporation under contract to LEAA. Inquiries by researchers should be directed as under:

General bibliographical and information services

General bibliographical and information services of utility to police researchers readily fall into either of two categories:

- a. bibliographic services, and
- b. information services.

Bibliographic services of substance are fairly rare. There are any number of bibliographies available upon a tremendous range of police topics far too numerous to even attempt to list in this publication. There are a number of people, too, who specialise in the production of bibliographies. However, we are concerned here with substantial producers of bibliographies:

- a. AIC
- b. NCJRS, and
- c. FBI.

AIC produces bibliographies upon request, specialising in Australian material. It maintains a clearing house of Australian criminological material known by the acronym of CINCH. A comprehensive introduction to this service is given at Annex P. CINCH searches are performed without charge, and should be requested from:

NCJRS is an international clearing house for criminal justice information. It compiles bibliographies upon request from its multilanguage data base. It also prepares an annual document retrieval index which is of considerable utility (see Annex D) to researchers.

AN INTRODUCTION TO CINCH

CINCH (Computerised Information from National Criminological Holdings) is a computer-based bibliographical information system which provides or will provide a number of services relevant to Australian criminology including:

1. The quarterly *Information Bulletin of Australian Criminology* as a current awareness publication.
2. Retrospective searches of the literature by topic, author, or journal on request.
3. Publication of all or part of the data base together with various indexes to enable information retrieval without access to the computer.

The Data Base

The aim of the Australian Institute of Criminology is to compile a bibliography of Australian criminology, involving the collection of *citations* to Australian material rather than the *material* itself. 'Australian' in this context means information published (or unpublished):

1. in Australia
2. overseas, but relating to Australia
3. by Australians working overseas
4. by foreign academics working in Australia.

'Criminology' is left undefined because of the amorphous nature of the subject matter and to allow for new developments in the discipline.

Work on the collection of citations has been in progress for nearly 1½ years and commenced with a methodical, cover-to-cover search of the major criminological journals in Australia. Citations within these journals to other relevant materials were noted for verification and further searching at a later date.

At present approximately 4,000 citations to journal articles, book reviews, editorials, letters and notes of a substantive nature make up the information base. A list of the major journal sources of Australian criminological information is published in vol 4, no.1 of the *Information Bulletin of Australian Criminology*.

Bibliographical details of monograph materials including books, government and research reports and theses are planned for inclusion in the data base in the near future, to be followed by newspaper article citations. Other sources of information planned for inclusion include case reports and commentaries, parliamentary debates and historical government reports.

Because the J.V. Barry Memorial Library was only established in 1973, its holdings are not always sufficient to allow it to provide a complete document back-up. Availability of journal articles can be sought through most libraries by the use of SALSSAH (Serials in Australian Libraries Social Sciences and Humanities), and SSAL (Scientific Serials in Australian Libraries).

The availability of holdings of criminological journals in Australia will be enhanced by the union list of serial holdings of Australia's criminological libraries at present being undertaken by the Monash University Law Library. A union list of monograph holdings of the same criminological libraries is being compiled by the J.V. Barry Memorial Library. The monograph citation retrieved from the CINCH data base will include the locations from the union list.

It is expected that the data base will grow at a rate of approximately 500 new citations per year, in addition to 'retrospective' citations discovered through historical searches.

Indexing Process

Material published since 1975 has been sighted by the indexers. Earlier material has mostly been indexed from title. A list of subject words used is being developed by the indexers. There are now more than 1,000 subject words being used in indexing. These words can be used both separately and in combination.

Search Requests

Requests for searches need not be limited to 'subject', as searches can also be made by reference to particular authors, journals, periods of time, citation categories or combinations of any of these.

Computer-based retrieval systems do not magically deliver answers at the push of a button, for the success or failure of such systems is less dependent on the machines involved than on the effort put in by the researchers, the indexers and, most importantly, by the person requesting the search. The computer in a retrieval system acts only as a high-speed matching device, matching the subject words given to the articles or monographs against the subject words which have been used in formulating requests. Retrieval only occurs when there has been a match.

It should be remembered that the majority of items in the data base will not be relevant to a particular search. The aim of a search will be to retrieve as many *relevant* items as possible, not simply as *many items* as possible. A very broadly based search may yield a great number of items, many of which will not be of value, while a specific search may retrieve relatively few citations most of which will be relevant. Thus, the aim of a computer-search is precision rather than quantity.

A copy of a CINCH Search Request Form is included in this Introduction. All search requests must be made on these forms which are available from the J.V. Barry Memorial Library. The forms have been designed to obtain as much information as possible relating to a request, to enable an appropriate, specific bibliography to be retrieved.

Effective Use of the System

To make the best possible use of the system a user must be prepared to exert some effort in making his exact needs known.

Section 1 of the Search Request Form requires a detailed statement of the subject of the search. Once again *specificity* is stressed and the user is asked to define terms which may have special meaning to him. Of great importance is an indication of what is *not* required, as this will help to narrow the search.

Section 2 provides check-off boxes which will help limit the search. The aim is to obtain the material that is relevant to the *user's* needs, not all the material which may be available.

Section 3 asks that citations known to be relevant are provided. These citations help clarify the user's specific interest.

Evaluation

CINCH is still in its early stages of development. As yet, the data base only includes journal citations. Consequently, the bibliographies retrieved will not be comprehensive of all Australian material.

It is important to the functioning of CINCH to receive an indication from users as to the relevance of the citations retrieved. This permits us to improve the system and provide users with searches more suited to their needs.

Charges

At this stage the service is provided free but financial circumstances may alter and it may become necessary to impose a charge to cover expenses.

Time

Subject to the volume of requests, the availability of staff and the postal service, it is expected that searches will be completed within two weeks.
